### Lodging:

The \$700 we are requesting for lodging will be used to pay for either a hotel or group Air Bnb in San Diego to lodge the 16-18 members we take on the night of Saturday April 29.

#### Vehicle Rental:

Due to limited members owning cars and availability to drive we will need to rent an 8 seater van from enterprise that we need assistance in covering the cost for. We intend to allocate \$300 of the given budget to help rent a van for 3 days and 3 nights.

#### Gas:

In order to send our goal of 16-18 members we will need to send a minimum of 3 vehicles to transport members. The estimated total mileage of the trip will be 890 miles, among 3 cars we estimate gas expenses to be around \$330.
